## **UNITED STATES EXTREME SKIM ASSOCIATION (USXSA) Membership Terms & Conditions (T&C's)**

### **1.0 Membership:**

- a. United States Extreme Skim Association (hereinafter just "USXSA") is **NOT an insurance company**.
- b. Applicant's membership fee is NON-REFUNDABLE. NO EXCEPTIONS and is separate and unrelated to session fees.
- c. **A \$10.00 fee will be charged to replace LOST Membership Cards. NO EXCEPTIONS.**
- d. USXSA "anniversary date" is one year from date of membership enrollment and membership fees paid in full.
- e. All persons joining USXSA must have active membership in good standing to be eligible for any and/or all benefits that may apply to members during membership period, including park access, training sessions, and all other USXSA programs, events, and activities.
- f. Member is responsible for "Proof of USXSA Membership" receipt during membership card processing for entry into parks.
- g. Members must be in full protective gear when participating in extreme skim sport activity in any manner including but not limited to: Helmet; Gloves; Knee, Elbow, & Wrist Guards/Braces or Pads; and Shoes or Boots.
- h. Members participating on extreme skim ramps (i.e. Quarterpipe, Half-Pipe, Jumps, Big Air, etc.) are required to wear at all times Torso/Spine/Body Armor/Protection. NO EXCEPTIONS.
- i. USXSA Member(s) attempting to or giving their membership card to another person to use, using a membership card of another member, attempting to use a fake USXSA membership card, and/or bringing Members into USXSA activities & events and its SKIM X affiliate which do NOT have active USXSA memberships, may have membership immediately terminated for up to one year from date of occurrence. Any additional persons participating in fraudulent, illegal, and dishonest activity may be ineligible for USXSA membership for up to one year, and be subjected to legal action taken by USXSA and its SKIM X affiliate.
- j. Members MUST show Valid ID with USXSA Membership card upon entering USXSA activity & events and SKIM X Park.
